4 New Features

4.1 Camp 2024 System Scope

The following items will be updated in this release:

- Camp deadline will be updated to June 30, 2024 throughout the application and links.
- Portal users receive validation message if they try to submit a Portal Application after 06/30/2024 at 11:59 PM.
- Anywhere, including but not limited to popups/validations and calendars, in the Application for Financial Support toward CSOC Summer Camp Tuition that state 2023 will be updated to 2024.
- The system will prevent portal users from submitting CSOC Summer Camp Services applications after the 06/30/2024 application deadline.
- Applications left in the In-progress status will be expired on 10/01/2023.
- The CSOC Summer Camp Services application on the Portal will be available for users on 10/19/2023 at 11:59 PM.
- On 10/19/2023 after midnight the Batch job will run to set the Camp Deadline date (06/30/2024) in the system to make the camp application available to create.
- The system will change the status of "Not Submitted" camps on 07/01 yearly.
- Additional language will be added to the My Portal tab:
 - "Application status notifications will be mailed out twice for the 2024 camp season, the first after December 1, 2023 and the second after March 1, 2024. In addition, reminders of the previously sent application status notifications will be mailed out after May 31, 2024."
- The PerformCare phone number will be displayed in the Camp and One-to-One Camp Request Pages for users to apply for Alternative Recreational Sessions (ARS).

- The CSOC Summer Camp Tuition Rates will be updated for Day Camp, Overnight Camp and One-to-One Aide in the Add/Edit Authorization screen, CMS 1500 claim form and Progress Note Notation Type Camp Services template.
- Progress Note Notation Type Camp Services template will be updated to display Calculated Approved Rate as per the new rate.

4.2 Camp 2024 Assumptions

- All changes to an Application for CSOC Summer Camp Services once in a Submitted status will be manually done by the CSA.
- Portal User will be able to print the entire Application for Financial Support toward CSOC Summer Camp Tuition.
- CSA will be able to approve the CABS.
- Families will still be able to edit the application prior to submission.
- Camp Providers will not have access to CYBER.

4.3 ICD-10 Updates System Scope

The following items will be updated in this release:

- The added and revised ICD-10 codes and header codes will be available to be selected in CYBER (in the Diagnosis drop down of Search Diagnosis screen).
- The deleted ICD-10 codes must remain in the system for historical purposes but should not be available for selection.
- The revised ICD-10 behavioral health codes will have the new description as of the date of implementation.
- The revised behavioral health code where the description has changed will display the new description in a youth's record where previously selected (historic).
- The revised ICD-10 medical (physical health) codes where only the description has changed will display the new description for both newly added and existing (historic) diagnoses.
- The system will not allow a user to copy a deleted diagnosis.
- FY2024 ICD-10 codes will be listed in CYBER as ICD10, ICD10-BH or ICD10-BH+PH type.
- FY2024 ICD-10 CM codes related to Substance Use will be listed with the Type ICD10-BH+PH.
- FY2024 ICD-10 Behavioral Health codes will be listed with the Type ICD10-BH.

4.4 ICD-10 Updates Assumptions

- All other ICD-10 codes will remain unchanged.
- ICD-10 codes are not included in the authorizations created in CYBER.
- CYBER access to view and add diagnoses remains unchanged.
- ICD-10 codes for the Autism Spectrum Disorder (ASD) Benefit and the Children's Support Services Program Intellectual Developmental Disability (CSSP IDD) waiver have not changed.
- The ICD-10 Codes are not an exact match to DSM V diagnosis codes, one cannot determine if a "non-billable" code is cross walked to a DSM V Diagnosis all codes (including Header codes) must be loaded into CYBER.
