WO 303139 FB 29496	<b>ISSUE:</b> The Welcome Page has no System Admin information for DCPP on the left corner just the way we have it for other User type login page.
	<b>RESOLUTION</b> : DYS users have the System admin name on the welcome page
WO 307700 FB 29522	<b>ISSUE:</b> Request is to add a pop up in Auth Print selected or Print provider selected when no auth is selected
	<b>RESOLUTION</b> : Pop up added in Auth Print when no authorization is selected.
WO 307087/306946 FB 29508	<b>ISSUE:</b> System Admin info needs to show on all Login type's Welcome pages.
	<b>RESOLUTION</b> : System Admin info is now on all user types Welcome pages.
	<b>ISSUE:</b> CSOC Confirmed the following rules for MLTSS functionality.
WO 296231 FB 29521	<ul> <li>The overarching rule for MLTSS TE closing should be the youth age. The system will close MLTSS TE based on the existing rule for the youth that turned 21.</li> <li>In the scenarios when the youth turns 21 and Medicaid feed is loaded with new SPC codes (codes that trigger MLTSS TE when the youth is under 21), the system will load SPC codes, but will not open MLTSS TE.</li> <li>If SPC end dated because of age, the system should not update MLTSS when SPC TE closed.</li> </ul>

<ul> <li>If youth is under 21 age (or cut off age limit), MLTSS TE will be closed based on existing TE rules (Inactive TE) and SPC TE End date.</li> <li>For data clean up – CSOC confirmed that we should add MLTSS TE End date based on the current rules for the youth that turn 21.</li> </ul>
<b>RESOLUTION:</b> Above rules have been implemented.

WO 303311 FB 29463	ISSUE: When CSA creates an Episode for FSS, the youth's Address is being updated with the provider address and Youth's Address Type is updated to "Out of Home Treatment Address". Adding an FSS Episode should not change the youth's address.  RESOLUTION: Youth address now does not change when adding an FSS episode.
WO 306369 FB 29491	ISSUE: INITIAL ISP PRINT- Youth's current address is displayed instead of former address.  RESOLUTION: Print now displays the correct address, which is specified on the plan.
WO 306638 FB 29489	ISSUE: LEGACY BPS PRINT- throws Sub report error.  RESOLUTION: Print report has been fixed to correct the Sub report error.
WO 305228 FB 29472	ISSUE: Reported issue regarding non receipt of Password Reset Emails.  RESOLUTION: Corrected this issue by trimming any space before and after email ID field.
WO 305772 FB 29468	ISSUE: Call Resolution navigation- Progress Note committed doesn't navigate directly to Call resolution tab if there is a call.  RESOLUTION: Creating Progress Note and upon commit- takes the user to Call Resolution.
WO 306153 FB 29466	<b>ISSUE:</b> IIC BPS Assessment AGING Report shows the record which doesn't belong to this provider.

	<b>RESOLUTION:</b> Now stored procedure changed to include only that agency's authorizations in Aging report.
WO 305805 FB 29458	ISSUE: When creating a BSP in triage and in Need Assessment Referral window the Specifiers (specialties) section is not shown where selection can be made.  RESOLUTION: Specialties grid now shows up to select.
WO 305396/304491/304265 FB 29207	ISSUE: Call is associated with Triage but it didn't get auto resolved upon Triage Submission.  RESOLUTION: Fixed script errors and set the Internet Explorer Delete browsing history to solve this problem. Unresolved Triage calls and FSS Apps now gets auto resolved upon triage submission.
WO 225014 FB 26364	ISSUE: User is reporting that the Phone2 field in Provider Details is not retaining the correct phone number format. User updates the phone number in Phone2 and clicks Save, it looks correct but if you leave the screen and then return the format is incorrect.  RESOLUTION: This is fixed, the phone number format is now correct for Phone1 and Phone2.
WO 307808 FB 29524	ISSUE: Unable to delete information in a Needs BPS. Deleted information in BPS keeps coming back on saved BPS.  RESOLUTION: Deleted information is being deleted on in progress BPS- Narrative section.
