4 New Features:

4.1 CYBER BCBA-D Code and Expansion of PE number Scope

The following changes will be implemented in CYBER related to the BCBA-D Code and Expansion of PE number range:

- A new bundle code will be added to the system.
- The service code CSC34 is added to the provider according to their Provider Type and Specialty.
- The system must provide the ability for a CMO to request CSC34 service code through the plan of care.
- The system must not auto route any CMO plan of care that has a request for the CSC34 service code.
- The authorizations created by the CSA for CSC34 service code must be prepopulated with certain information.
- The system will create the Tracking Element for service code CSC34 on the Security Tab.
- The system will create the Episode of Care for service code CSC34 on the Episodes Tab.
- The system will prohibit the user from submitting a treatment plan or authorizing services if the start date of the service request is prior to the effective date of the service code.
- The system will prohibit the user from submitting a treatment plan or authorizing services if the end date of the service request is after the expiration date of the service code.
- The system will prohibit a user form submitting a treatment plan or authorizing services if the start date of the Service Request is prior to the effective date of the service code and the End Date of the Service Request is after the expiration

- date of the service code.
- Youth with an ASD diagnosis, identified MCO eligible Medicaid #'s must receive ABA services through the Medicaid Managed Care Organizations (MCO).
- The system will prohibit the user from submitting treatment plan to CSA when ABA services are present in the treatment plan for youth with MCO eligible Medicaid #.
- The system will warn/allow the user when CSA authorizes ABA services or approves treatment plans with ABA services for youth with MCO eligible Medicaid #.
- The current range of Presumptive Eligibility (PE) numbers will be expanded by DMAHS by August 2020.
- CSC 34 and two new Behavior Consultative Supports Service Codes for BCBA-D will be added to Service Codes covered by the CSSP I/DD wavier.
- Presumptive Eligibility numbers that do not qualify as a Medicaid Number will be updated to ensure that they are not enrolled in CSSP I/DD as PE is not eligible for the waiver.

4.2 Assumptions

The following are the assumptions related to this release:

- Services will be requested via treatment plan from CMO.
- The current validations on the service request screen remains unchanged.
- The current validations on the Add/Edit authorization screen remains unchanged.
- The current validations when submitting the treatment plan will remain unchanged.
- There will be no split authorizations and DXC will approve the authorizations submitted with Service code 96152HA.
- The bundle code will be added to the CSPP IDD waiver and they should serve as a trigger/qualifier.
- The effective start date of CSC34 bundle code and expiration date of 96152HA service code is TBD by CSOC.
- The Service Code is based on the Specialty IIH_BEH. This is manually attached to the provider by the service desk to associate it to the correct provider.
