Eligibility 3560 - All user types have the "Add Insurance" button enabled in the 3560 for youth in Historical Access. "Add Insurance" button needs to be disabled for users viewing youth in Historical Access. Note: Eligibility button will not be visible for youth in Historical Access until after you click the youth's "Forms" button. Edit Supports - All user types are able to edit Supports for Historical Access youth by double-clicking on an existing Support which opens the Add/Edit Support Member screen. Accept button is enabled allowing users to make changes to the Supports. The Accept button needs to be disabled to prevent the user from making changes. RESOLUTION: The reported issue is resolved. Providers with Historical Access are not able to edit the stated areas in CYBER.
