4 New Features:

4.1 CYBER CAMP 2023 System Scope

The following items will be updated in this release:

- The Camp Application on the Portal will be available for users on March 31st 2023 at 11:59 PM
- On March 31st 2023 after midnight the Batch job will run to set the Camp Deadline date to (6/30/2023) in the system to make the camp application available to create
- Camp deadline will be updated to June 30, 2023 throughout the application and links
- Application status notifications will be mailed after May 1, 2023
- The Authorization start date is set to the second Saturday of June and the authorization end date is set to the second Saturday of September

4.2 Assumptions

- All changes to an Application for CSOC Summer Camp Services once in a Submitted status will be manually done by the CSA.
- Portal User will be able to print the entire Application for Financial Support toward CSOC Summer Camp Tuition
- CSA will be able to approve the CABS
- Families will still be able to edit the application prior to submission.
- Camp Providers will not have access to CYBER.
- Portal pages, documents/text, dates and the validation on the number of day camp and overnight camp dates embedded in the pages and documents should be easily changed since next year there will be different dates.
- The Camp Application on the Portal will be available for users on March 31st 2023 at 11:59 PM.

- On March 31st 2023 after midnight the Batch job will run to set the Camp Deadline date to (6/30/2023) in the system to make the camp application available to create.
- Portal users will not be able to create an Application for Financial Support toward CSOC Summer Camp Services Tuition after the 6/30/2023 deadline. If they attempt to create one they will receive a validation.
- Users will only be able to create one application per child for Financial Support toward CSOC Summer Camp Services per year.
- All colors and font will remain the same on the Family Portal.
- When users click the link to the Family Portal from the PerformCare Website they will still be brought to the Log in Page.
- The CSA will continue to be able to create an Application for Financial Support toward CSOC Summer Camp Services from the Forms grid of a youth's Face Sheet.
- Anywhere, including but not limited to popups/validations and calendars, in the Application for Financial Support toward CSOC Summer Camp Tuition that state 2022 will be updated to 2023 and will be updated annually for the Camp Season to reflect the current year and submission by June 30 of the current year.
- New/Existing Camp Providers are set up manually by the Service Desk off a spreadsheet provided by CSOC through the Add/Edit Provider Details screen.
- All the grids within the application shall be sortable.
- The Applications grid will be able to be sorted by clicking on a column header.
- Links for information on Using the Portal, Frequently Asked Questions for the Developmental Disability Eligibility Application and CSOC Summer Camp Services, Technical Assistance and System Requirements will be provided prior to the annual Camp season after review for needed updates.
- The System notification users receive upon application submission is updated to reflect June 30th without the year.
- Applications with the derived status of in Progress will be expired on 10/1 of each year.
