5 New Features

CYBER Release 2.0.0.18.2 DB 25.0.0 includes implementation of CSSP I/DD Waiver Updates – Phase 1 and Annual Camp Updates – 2025.

5.1 CSSP I/DD Waiver Updates - Phase 1

The following changes have been made in CYBER as a part of the implementation of CSSP I/DD Waiver Updates – Phase 1:

- The automated waiver eligibility algorithm will be modified to include youth under age 21.
- The automated waiver eligibility algorithm will be modified to exclude youth with Special Program Code (SPC) 12.
- The number of days will be increased from 30 to 45 for the I/DD waiver covered service

- authorizations to be active for the youth.
- New document type "CSSP I/DD Waiver" and subtype "Enrollment" will be added to the system for Care Management Organization (CMO), Contracted System Administrator (CSA) and Children's System of Care (CSOC) users to upload CSSP I/DD waiver enrollment form that will be completed by CMO Presumptive Eligibility (PE) coordinators.

5.2 Annual Camp Updates - 2025

The following changes have been made in CYBER as a part of the implementation of Annual Camp Updates – 2025:

- The CSOC Application for Financial Support toward Summer Camp Tuition on the Family Portal will be available for users on 08/31/2024, at 11:59 PM.
- The system will prevent portal users from submitting CSOC Application for Financial Support toward Summer Camp Tuition applications after 06/30/2025 application deadline.
- Applications created by CSA and portal user with "In Progress" status has expired on 08/01/2024 and will continue to expire on 08/01 each year.
- Any application created by a portal user (family created application) that are in an "In-Progress" status will be updated to "App Expired" status annually on 07/01 and pop window will display as "Application Expired".
- The CSOC summer camp tuition rates will be updated for Day Camp and Overnight Camp in the Add/Edit Authorization screen, CMS 1500 claim form and Progress Note Notation Type Camp Services template.
- The text in My Portal and Instructions/Demographics tab will be modified.
- The authorization start date will be set to the second Monday of June and the authorization end date will be set to the second Saturday of September.
