5 New Features

CYBER DB 26.0.0 includes implementation of ICD-10 codes for FY2025, addition of 4 document sub types to the existing CSSP I/DD Waiver document type, addition of the current school year to QPUs, rate updates FY2025 and bug fix for Strength and Needs Assessment (SNA) fix for Care Management Organization (CMO) Annual Review plans.

5.1 ICD-10 Updates for FY2025

The following changes will be made in CYBER as a part of the implementation of ICD-10 Updates for 2025:

- The added and revised ICD-10 codes and header codes will be available to be selected in CYBER (in the Diagnosis drop down of Search Diagnosis screen).
- The deleted ICD-10 codes must remain in the system for historical purposes but should not be available for selection.
- The revised ICD-10 Behavioral Health (BH) codes will have the new description as of the date of implementation.
- The revised behavioral health code where the description has changed will display the new description in a youth's record where previously selected (historic).
- The system will not allow a user to copy a deleted diagnosis.
- FY2025 ICD-10 codes will be listed in CYBER as ICD10 or ICD10-BH.
- FY2025 ICD-10 Behavioral Health codes will be listed with the Type ICD10-BH.

5.2 Rate Updates FY2025

The following changes will be made in CYBER as a part of the implementation of Rate Updates FY2025:

- The FY2025 rates will be updated for the impacted service codes.
- Per Unit Cost (optional) field will display the new rate in the Add/Edit Authorization screen for the impacted service codes.
- The Cost per Unit field will display the new rate in the CMS 1500 claim form for the impacted service codes.

5.3 Addition of 4 New Document Sub Types to CSSP I/DD Waiver Document Type

The following new document subtypes will be added under the CSSP I/DD Waiver document type for Contracted System Administrator (CSA), Care Management Organization (CMO) and Children's System of Care (CSOC) users.

- Eligibility Notice
- Disenrollment
- Disenrollment Notice
- Update

5.4 QPU School Year

Current school year will be added to "School Year Completed" dropdown list in all Behavioral Health Home (BHH) Quarterly Progress Update (QPU) Assessments.
