- **3560 for PE Coordinators** – 3560 application, review, approval, and termination process, related Welcome Page links.
- **Adolescent Housing Hub (AHH)** – AHH Link, admitting and transitioning youth, managing census.
- **Annex A Addendum Administrators (type of Out of Home Providers)** – creating, modifying and submitting Annex A Addendum.
- **Behavioral Health Home (BHH)** – Nursing Assessment, QPUs, progress notes.

- **MultiSystemic Therapy/Family Functional Therapy (MST/FFT) Partial Hospital Provider /Children’s Crisis Intervention Services (PHP/CCIS)** – Needs Assessment, Authorization.
- **Open Forum Q&A** – Opportunity for providers to ask any technical questions about CYBER.
- **Out of Home (OOH)** – Strengths and Needs Assessment, OOH Treatment Plans, Progress Notes.
- **Security Administrator Functions** – Overview of the functionality for Security Administrators to create, activate, update, and deactivate CYBER users. Password unlock and reset functionality will be reviewed.
